*LAST DAY TO FILE PETITION WITH THE SECRETARY OF STATE FOR MINOR/THIRD PARTIES TO GAIN BALLOT ACCESS AS A POLITICAL PARTY NO LATER THAN 5:00 P.M. ON THE DAY OF THE PRIMARY ELECTION. [§17-6-22(a)(1)]
