*LAST DAY FOR MILITARY AND OTHER UOCAVA VOTERS IN THE PRIMARY TO POSTMARK AN ABSENTEE BALLOT RETURNED BY MAIL TO THE ABSENTEE ELECTION MANAGER. [§17-9-51(b); §17-11-18(b)].

*THE MEDICAL EMERGENCY DESIGNEE MUST DELIVER ABSENTEE BALLOT TO ABSENTEE ELECTION MANAGER NO LATER THAN NOON ON THIS DAY. [§17-11-18(a)].

*LAST DAY TO FILE PETITIONS WITH SECRETARY OF STATE (FOR STATE OFFICES) OR WITH THE PROBATE JUDGE (FOR COUNTY OFFICES) TO OBTAIN BALLOT ACCESS AS AN INDEPENDENT CANDIDATE. NO LATER THAN 5:00 P.M. ON THE DAY OF THE PRIMARY ELECTIONS. [§17-9-3]

*LAST DAY TO FILE PETITION WITH THE SECRETARY OF STATE FOR MINOR/THIRD PARTIES TO GAIN BALLOT ACCESS AS A POLITICAL PARTY NO LATER THAN 5:00 P.M. ON THE DAY OF THE PRIMARY ELECTIONS. [§17-6-22(a)(1)]
